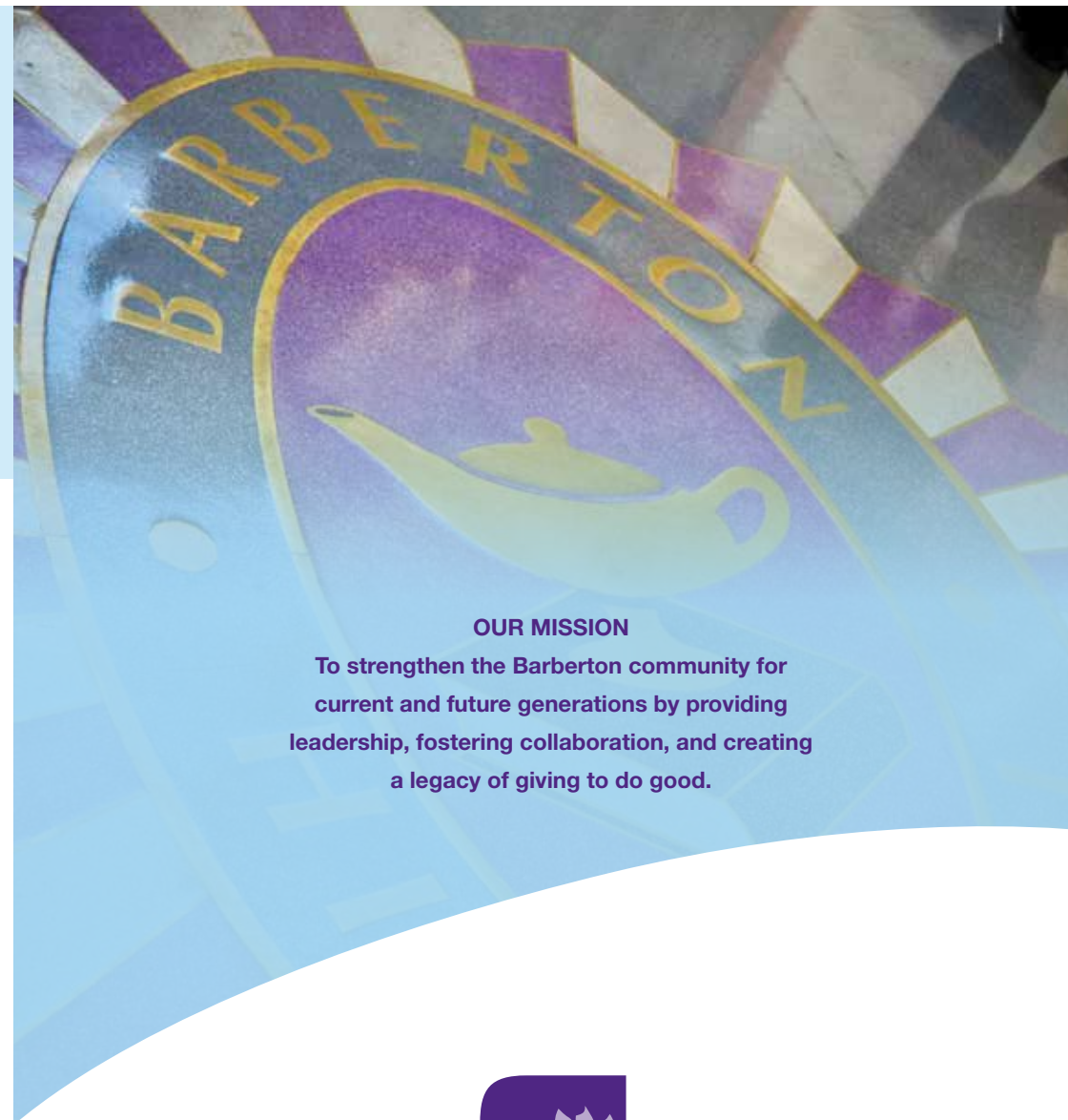

WHAT IS A COMMUNITY FOUNDATION?

A community foundation is a non-profit organization supported by donors with a common interest in charity and creating good in a defined geographic area. There are fewer than 800 community foundations in the U.S. - Barberton is fortunate to have its own.

TYPES OF FUNDS

GENERAL FUND

In addition to our general operating fund and assets, scholarships and community initiatives are powered by this fund.

ENDOWMENT FUND

Totalling a minimum of \$5,000 within five years of opening, Endowment Funds are directed at a Barberton-based cause of your choosing.

PASS-THROUGH FUND

A flexible way to support your personal giving goals, a Pass-Through Fund acts as a charitable checking account – with the potential for immediate impact.

FUND CATEGORIES

Endowment and Pass-Through funds are available in the following categories:

DESIGNATED

As the donor, you may support one or more specific charitable organizations that benefits Barberton.

FIELD OF INTEREST

As the donor, you choose to invest in a specific cause or initiative you wish to support that benefits Barberton.

DONOR-ADVISED

As the donor, you may choose how distributions are directed within Barberton annually.

SCHOLARSHIP

As the donor, you may set-up a fund that assists Barberton residents with the cost of higher education.

GIVING WITH GOALS

Not ready to give now? You can still plan your future partnership with the Barberton Community Foundation. Here are some ways you can plan your giving:

MARKETABLE SECURITIES

Gifts of appreciated stock or other securities may be made to the Foundation for an immediate tax benefit.

BEQUEST

Name the Foundation as a beneficiary in a new will, or modify an existing will.

LIFE INSURANCE

Name the Foundation as a beneficiary in a new or existing policy.

CHARITABLE REMAINDER TRUST (CRT)

You can establish a trust for the ultimate benefit of your fund at the Foundation while receiving annual tax benefits.

RETIREMENT ACCOUNTS

A charitable gift from your retirement plan account or IRA, during your lifetime or end of life, may provide significant tax benefit to you or your beneficiary.

CHARITABLE LEAD TRUST (CLT)

Allows you to provide income to your fund for a specified number of years. The benefits of a CLT include the transfer of assets to others free of estate, gift, and income taxes.

REAL PROPERTY

Allows you to transfer property to the Foundation through your will.

Please contact the Foundation if you are thinking about any of the options listed above. In most cases, the tax benefits outweigh using your assets to establish your own private foundation.

Your donations support our community and help grow the Foundation to better manage the changing needs of Barberton.
